FOR BEST RESULT

Install a minimum 4' by 4' test area site mock up for approval of acceptable color, texture, finish, adhesion, and any other critical requirement acceptable to the owner prior to proceeding with the installation.

Verify current versions of product technical data sheets (PTDS), material safety data sheets (MSDS), and installation guidelines (IG) at <u>www.miracote.com</u>.

Protect materials from excessive heat and cold and regularly check wet film thickness with mil gauge and monitor consumption to ensure correct application thicknesses and rate are obtained.

OVERVIEW OF INSTALLATION

• Apply two coats by brush, roller, conventional or airless spray. Strain material before spray application. Allow for losses due to application methods, conditions and surface irregularities. Dries to touch in approximately 20 minutes. Allow 4 hours dry time between coats.

Caution: Miracote MiraGard Colorbond XL's slip resistance characteristics can be reduced when used in conjunction with other Miracote sealers.

LIMITATIONS

• Apply only to clean, relatively dry surfaces.

MAINTENANCE

For maximum sheen and cleanability, floor should be routinely treated with conventional maintenance finish followed by ordinary buffing.

SLIP RESISTANCE and CLEANABILITY

In general, the more aggressive the finished surface the greater the coefficient of friction and corresponding slip resistance, the more difficult to clean. The smoother the finished texture the easier the surface is to clean, but there is a loss of skid resistant properties.
