



**STEP 1**

**ASSEMBLE BASKETBALL UNIT**

*NOTE : To avoid scratching the backboard, it is required to have 2 people assembling the unit on a carpeted or padded floor.*

*NOTE : Before assembling the unit , place a drop of oil on the threads of the bolts to avoid the nuts from getting stuck*

- Attach rim and backboard to post as pictured (C), using four 5/16" x 1 1/4" carriage bolts, four 5/16" washers (C1), and finger tighten using four 5/16" lock nuts on back of post plate (C2).
- Make sure the square shoulder under the bolt head (C) is fully inserted into the square hole in the rim plate.
- Put net on rim.

**STEP 2**



**SECURE BASKETBALL UNIT TO ANCHOR**

- Adjust anchor bolt so brass wedge in anchor is in its lowest position. Put finishing ring on basketball post and lower post into anchor and adjust so keyed bottom of post drops and interlocks. Tighten anchor bolt (B1) with wrench until tight. Adjust backboard and rim so they are straight and then tighten 4 nuts with wrench (C2).

**STEP 3**


**REMOVING BASKETBALL UNIT**

- Lift up finishing ring and loosen anchor bolt (B1), tap bolt head with wrench and loosen all the way so brass wedge is in lowest position.
- Remove post from anchor and push anchor cap into anchor. Be careful when storing backboard to avoid scratching the surface.
