

# SAFETY COVER WARRANTY

The manufacturer warrants the safety cover to be a product of the finest workmanship. Subject to conditions set herein, the manufacturer agrees at its option to replace or repair any component which, to our satisfaction, proves defective either in workmanship or material, F.O.B. its factory, from the original date of purchase within the warranty periods listed below. After the full warranty period expires, the same will be supplied or repaired, at the manufacturer's option, upon payment of a charge in accordance with the then retail selling price. The following schedule sets forth the percentage of the retail price according to the type of cover purchased.

<b>PREMIUM MESH OR SOLID SAFETY COVER: 15-YEAR LIMITED, 3-YEARS FULL</b>	<b>STANDARD MESH: 12-YEAR LIMITED, 2-YEARS FULL</b>	<b>ECONOMY MESH OR SOLID SAFETY COVER: 10-YEAR LIMITED, 1-YEAR FULL</b>
First 3 years----- 0%	First 2 years----- 0%	First year ----- 0%
4 to 8 years ----- 50%	3 to 6 years ----- 50%	2 to 5 years ----- 50%
9 to 15 years----- 75%	7 to 12 years----- 75%	6 to 10 years----- 75%

## Limitations and Exclusions:

This warranty relates only to manufacturing defects and does not cover discoloration, damage or failure resulting from other causes, including, but not limited to, acts of God, improper installation, improper maintenance, use during snow season with the pool water more than 18" below the pool coping, misuse or abuse, consumer negligence, design alteration, accident, fire, ice, exposure to excessive heat or cold, water loss, material breakdown due to sun degradation, mildew and natural aging.

The manufacturer is not liable for freight, installation, service or labor costs.

## Additional Exclusions:

- Material damage or fading due to sun or chemical exposure
- Damage caused by animals
- Tree limbs or other sharp objects piercing cover
- Burn holes caused by reflection, burning leaves, cigarettes, etc.
- Abrasions from excessive wind moving cover or abrasion from rough coping.

Although any warranties implied are limited to the stated period after the date sold to the original purchaser, some states and/or provinces do not allow limitations on the length of time of an implied warranty. Therefore, the above may not apply in such states and/or provinces. Any claimant under this warranty has specific legal rights and the provisions of the warranty are neither a modification nor subtraction, but rather, an addition to the statutory warranties and other rights and remedies contained in the applicable state or provincial legislation.

The manufacturer will not be liable for any incidental or consequential damages resulting from any defects in workmanship or material. Some states and/or provinces do not allow the exclusion or limitation of incidental or consequential damages, therefore the foregoing limitation or exclusion may not apply.

This warranty gives the original consumer purchaser specific legal rights. The purchaser also has implied warranty rights. In the event of a problem with warranty service or performance, you may be able to go to a small claims court, a state court or a federal district court.
