

# EIGHT YEAR COVER WARRANTY

Cypress, Inc. warrants this cover to be free of defects in workmanship. Examine your cover carefully before installing. Handle your cover carefully during inspection and installation as the manufacturer is not responsible for tears or punctures caused by improper handling.

Cypress, Inc. pool covers are warranted free of defects for a period of eight (8) seasons from date of purchase on a pro-rata basis, based on the manufacturers suggested retail price each season to end on April 31. Replacement under these warranties is as follows:

<b>FIRST SEASON</b>	<b>NO CHARGE</b>
<b>SECOND SEASON</b>	<b>40%</b>
<b>THIRD SEASON</b>	<b>75%</b>
<b>FOURTH SEASON</b>	<b>85%</b>
<b>FIFTH SEASON</b>	<b>90%</b>
<b>SIXTH THRU EIGHTH SEASON</b>	<b>95%</b>

It is expressly agreed that there are no warranties expressed or implied made by the dealer or Cypress, Inc. except as stated above. Cypress, Inc. will not be responsible for any labor charges, cost of loss of water or chemicals, or any other damages that may occur therefrom. **ALL COVERS SHOULD BE RETURNED DIRECTLY TO CYPRESS, INC.** Any return of merchandise under the terms of this warranty must be authorized in advance and be returned freight prepaid.

Every pool cover is thoroughly inspected before shipment. Should a defect in manufacture become apparent within thirty (30) days of purchase, please ship via parcel post to Cypress, Inc. Cover will be returned promptly and without charge.

Should cover fail in normal use within eight (8) years of purchase date, return to Cypress, Inc. prepaid, and include two dollars for handling and postage. If cover can be repaired, it will be repaired and returned. If it cannot be repaired, credit will be given on time elapsed from purchase date toward purchase of replacement.

Before returning cover, check the following:

1. Cover must be clean and dry. Return only the components that are at fault.
2. Include this guarantee and sales slip to prove date of purchase and amount paid, and a complete statement as to your complaint.
3. If cover was purchased over 30 days before mailing date, include \$2.00 check or money order to cover cost of return postage and handling.
4. Send by parcel post or express, prepaid. Collect shipments will be refused.
