DESCRIPTION

Techniseal® Organic Stain Remover is formulated to remove moss and mildew as well as tough organic stains such as dead leaves, blood, wine and non-greasy food stains on concrete pavers, slabs and walls, natural stone, poured or stamped concrete, etc. Techniseal® Organic Stain Remover works without damaging or discoloring the material. It can safely remove the toughest stains. It is recommended for bare and sealed surfaces. It can safely remove the toughest stains.

DIRECTIONS

BEFORE YOU BEGIN

• Wear adequate protective clothing. Will discolor clothing if spilled. • **ALWAYS TEST** on a small hidden stain to ensure that result meets your expectations. (See Warranty). • **Do not** mix product with other chemicals. • Consult local authorities regarding the application of such products, waste management and run-offs. • **Do not** apply under blazing sun. **Never** let Organic Stain Remover dry on the surface; keep it wet until it is completely rinsed off.

PREPARATION

WETTING VEGETATION: To reduce the effect of Organic Stain Remover on vegetation, first saturate surrounding grass, shrub and plants with water.

DILUTION: Stain removal: Into a plastic watering can, dilute 6 scoops of Remover in one liter of warm water. The amount of Remover to be diluted will depend on the stubbornness of the stain. Large surfaces: Into a plastic watering can, dilute the entire container (25 oz) of Remover in 7.5 quarts of water.

APPLICATION

Stain removal: Apply a generous amount of diluted Organic Stain Remover on a stain. Let work 5-10 minutes. Scrub stain using a small Techniseal® brush. Rinse thoroughly and let dry. Repeat if necessary.
Large surfaces: Cover surface with diluted Organic Stain Remover. Scrub using a long-handled brush. Rinse thoroughly and let dry. Repeat if necessary. If rinsing to an adjacent surface, the adjacent surface must be rinsed thoroughly as well.

COVERAGE

25 oz of concentrated powder makes up to 2 gal. of solution and cleans up to 200 sq. ft. Coverage will depend on surface condition and dilution.

STORAGE

Store in cool and dry place.
