### SECTION 4: First-Aid Measures

#### If inhaled

### SECTION 6: Accidental Release Measures

#### Personal precautions, protective equipment, and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Wear appropriate protective equipment and clothing during cleanup. ### Methods and material for containment and cleaning up
